<u>ORDER</u>

Provisional Affiliation was granted for starting MBA programme with an intake of 60 students at SNES Institute of Management Studies and Research (Unaided), Chethukadavu, Kunnamangalam, Kozhikode (Dt.) during the academic year 2009-10 vide U.O read as first above.

2. The increase of intake has been granted to MBA programme at SNES Institute of Management Studies and Research from 60 to 100 with effect from the academic year 2012-13 vide U.O. read as second above.

3. All India Council for Technical Education (AICTE) has reduced the intake of the college from 100 to 60 seats for the academic year 2018-19 ,vide paper read as third above.

4. Continuation of Provisional Affiliation to the MBA programme for the academic year 2020-21 was granted with an intake of 60 students on conditional basis subject to the submission of renewal NOC from Government of Kerala for the year 2020-21, vide U.O. read as fourth above.

5.The Principal, SNES Institute of Management Studies and Research (Unaided), Kozhikode (Dt.), has applied for granting Continuation of Provisional Affiliation to MBA programme in the college for the academic year 2021-22 with an intake of 60 students, vide paper read as fifth above. An amount of Rs. 1,32,300/- (Rupees One Lakh Thirty Two Thousand Three Hundred only) has been remitted by the college towards administration and affiliation fee vide chalan No.202242370 dated 11.12.2020.

6. AICTE has extended its approval to the MBA programme for the academic year 2021-22 at SNES Institute of Management Studies and Research, Kozhikode with an intake of 60 students,vide paper read as sixth above.

7. Vide G.O read as seventh, Department of Higher Education, Govt. of Kerala has renewed the NOC for conducting MBA programme at SNES Institute of Management Studies and Research (Unaided), Chethukadavu, Kunnamangalam, Kozhikode (Dt.)for the years 2016-17 to 2017-18 with 120 seats and 2018-19 to 2021-22 with 60 seats.

8. The Principal has submitted the staff list with an undertaking as stipulated vide U.O read as eighth above.

9. Considering the above, sanction has been accorded by the Vice Chancellor on 15.06.2022, to grant Continuation of Provisional Affiliation to the MBA programme with 60 seats at SNES Institute of Management Studies and Research, Kunnamangalam, Kozhikode for the academic year 2021-22 and making the U.O read fourth as absolute, since the College has produced renewal NOC from the Govt. for the academic year 2020-21.

10. Following orders are, therefore, issued.

i) Continuation of Provisional Affiliation is granted to the MBA programme with 60 seats at SNES Institute of Management Studies and Research, Kunnamangalam, Kozhikode for the academic year 2021-22

ii) Continuation of Provisional Affiliation granted to MBA programme with 60 seats conditionally during 2020-21, vide U.O. read as fourth , is made absolute.

11. Affiliation granted is strictly provisional and only for the academic year 2021-22. The College has to apply for Continuation of Provisional Affiliation for the ensuing years by remitting the fee fixed by the University along with a copy of the Extension of Approval Order from the apex body concerned.

12. Selection and admission shall be made only on the basis of the rules and regulations of the University/Government and on the basis of the directions issued by the University/Government from time to time, failing which the affiliation granted will automatically be cancelled. Admission to the next academic year shall be made only after obtaining prior permission from the University.

13. The Principal is directed to strictly adhere to the UGC Regulations in engaging faculties in the college and Continuation of Provisional Affiliation for the next academic year will be considered accordingly.

14. The Office of the Controller of Examinations shall ensure that examinations are not conducted in the colleges without having valid affiliation orders.

15. The conduct of University Examinations of any sort including that of SDE Examinations is compulsory and binding on all Colleges affiliated to the University of Calicut.

16. In the light of the directions of the Supreme Court of India in WP(C) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent such instances, appropriate action including the withdrawal of affiliation of the college will be initiated.
