ORDER

Provisional Affiliation was granted for starting MBA programme with an intake of 60 students at SNES Institute of Management Studies and Research, Chethukadavu, Kunnamangalam, Kozhikode, during the academic year 2009-10, vide U.O. read as 1st.

2. The increase in intake has been granted to MBA programme from 60 to 100 with effect from the academic year 2012-13, vide U.O. read as 2nd.

3. Continuation of Provisional Affiliation was granted to this programme (with 60 intakes) for the academic year 2024-25, vide U.O read as 3rd conditionally subject to the submission of the renewed NOC from the Government of Kerala.

4. Vide G.O. read as 4th, the Department of Higher Education, Government of Kerala, has renewed the NOC for conducting the MBA programme for the academic year 2024-25.

5. The Principal has applied for Continuation of Provisional Affiliation to MBA programme for the academic year 2025-26 with an intake of 60 students, vide paper read as 5th.

6. AICTE has extended its approval to the programme for the academic year 2025-26 vide paper read as 6th.

7. Considering the above, sanction has been accorded by the Vice Chancellor

(i) to grant Continuation of Provisional Affiliation to the MBA programme with 60 seats at SNES Institute of Management Studies and Research, Kunnamangalam, Kozhikode for the academic year 2025-26 on conditional basis, with strict directions to follow the UGC regulations and comply the provisions under the Act 13 pf 2021, while engaging faculties, subject to the submission of renewed NOC from Government of Kerala for the year 2025-26.

(ii) making the U.O read as 3rd, as absolute since the College has produced the renewed NOC from the Government for the academic year 2024-25.

8. Orders are issued accordingly with the following terms and conditions:

- i. Affiliation granted is strictly provisional and only for the academic year 2025-26. The colleges must apply for CPA for the ensuing years by remitting the fee fixed by University from time to time, along with the extension of approval orders, if any, from the apex bodies concerned.
- ii. The Principal shall follow the syllabi available on the University website (www.uoc.ac.in)/approved by the University for selecting courses.
- iii. The courses in this order shall not be treated as a factor for calculating the workload for the subject or the requirement of teaching faculty, for which competent orders shall be obtained from the Government/University.
- iv. Selection and admission shall be made only on the basis of the rules and regulations of the University/Government and based on the directions issued by the University/Government from time to time.
- v. In the light of the directions of the Hon'ble Supreme Court of India in WP (C) 656/1998, the institution shall take appropriate measures for the prevention of ragging in any form. In case of failure to prevent such instances of ragging, appropriate action, including withdrawal of affiliation of the college, will be initiated.
- vi. The conduct of examinations is not permitted in colleges unless they have been granted the continuation of provisional affiliation or their application is under process.
- vii. The conduct of University Examinations, including S.D.E Examinations is compulsory and binding on all colleges affiliated with the University of Calicut.
- viii. The college is liable to comply with the general conditions stipulated in the renewed NOC from the Govt. of Kerala for the academic year 2025-26.
- ix. Admission to the next academic year shall be made only after obtaining prior permission from the University.
- x. No students shall be admitted to any course of instruction in the college in anticipation of affiliation.
- xi. Violation of any of the above may lead to the cancellation of affiliation.
